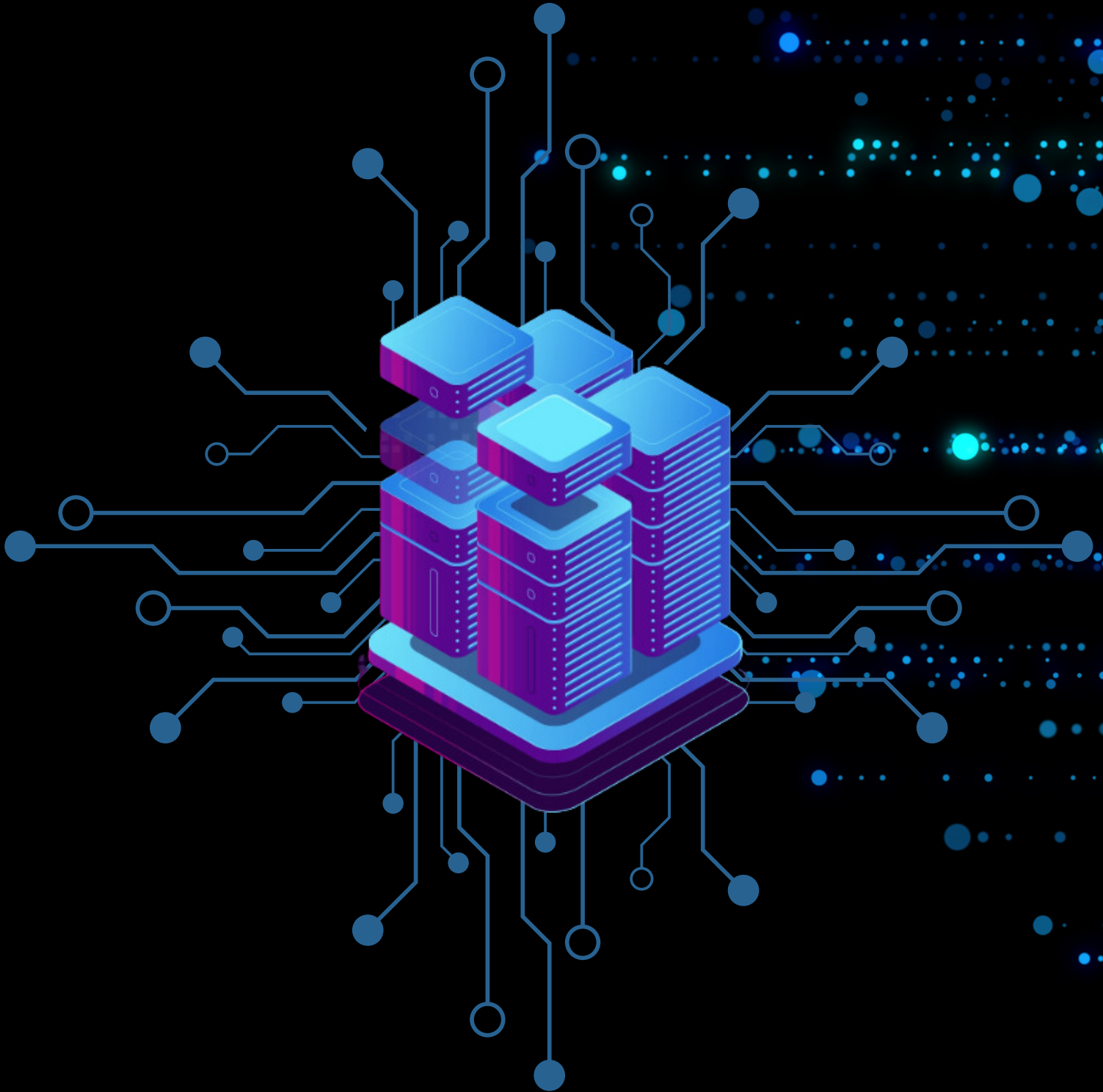

PRIVACY POLICY
