SECURITY POLICY

COPYRIGHT

The U.S. became a member of the Berne Convention on March 1, 1989. With this, copyright protection will be automatic, without the need for a formal requirement.

UCC - Universal Copyright Convention

The U.S. has been a member of the UCC since September 16, 1955, so unpublished works and those published by users who are nationals of member countries have the same protection of rights in other UCC member countries.

Bilateral Agreements

There are bilateral agreements between the US and other countries, where one protects the copyright of the other, in cases that fall within the scope of the Berne Convention and the UCC.

How long the Copyright lasts

The current law, in Us, lasts for the author's rights at 70 years after his death, 95 years after the publication of the work if it is created by coo participe, known as Wo for hire, or 120 years after the creation of the work.

In the case of works published/created/registered before the year 1978, the rules of copyright duration are cited in sunsteinlaw.com



O Fair Use

This term, under the copyright law of the United States of America, cites a limitation on actions that may not constitute copyright infringement.

The courts will analyze 4 factors to identify whether or not there has been copyright infringed by third parties, taking into account Fair Use, it will analyze:

- The purpose of the use of said material
- The worked proportion of the work
- The nature of the work performed
- The effect that will have on the market as a whole.
